# Realtor Procedures for Joining Stellar MLS as an MLS Only Member

Enclosed please find all the paperwork that you will need to fill out to join the Stellar MLS through the West Pasco Board of REALTORS®. The following criteria must be met before you can join as an MLS only Member:

- A Letter of Good Standing from your primary board must be submitted with your Membership Packet.
- Your Designated Broker must join as an MLS firm and all of his paperwork must be processed, so the company information is updated to the MLS.
- Once that is done, agents that choose to participate can turn in their application and fees to join.

- It could take up to 48-72 hours for your information to be processed and updated into the Stellar MLS. Once you are updated in Stellar MLS, you will receive an e-mail with your login information and how you can access the MLS Classes.
- Please look over the Stellar MLS class requirements (see attached) to participate in the MLS. You are required to complete the following classes within sixty days (Basic and Compliance). The Add/Edit Class is for anyone who will be entering their own listings.
- Once you complete the Add/Edit Class, your Broker must go online to Stellar MLS to give you that access level.

- If you are paying by check, you will have to give us two separate checks. One will be payable to: West Pasco MLS and the other will be payable to: Stellar MLS.
