- A Letter of Good Standing from your primary board must be submitted with your Membership Packet.
- Your Designated Broker must already be or join as an MLS member and firm and all of their paperwork must be processed, so the company information is updated to the MLS.
- Once that is done, agents that choose to participate can turn in their application and fees to join.
